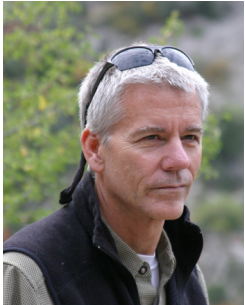
STEPHEN BLESSMAN

In 2011 he was named CEO of A Greener Solution which is an environmental management and consulting company specializing in landfill reduction and recycling options for manufacturing companies. A Greener Solution programs typically raise clients' recycling rates from 25 percent to 75 percent in less than one year and up to 90 percent within two years.

Render has spoken on recycling issues at many industry functions, including events organized by the Society of Plastics Engineers, Society of Plastics Industry Inc., Institute of Scrap Recycling Industries, Recycling Magazine and International Housewares Show.
